ON ACCEPTANCE

Registration Fee Payable upon receipt of Letter of Offer. This fee is non-refundable. MYR 3,000

Security Deposit Payable per student.
The deposit is refundable, subject to terms and conditions. MYR 5,000

TUITION FEE

The tuition fee is payable upon commencement of each term (3 terms per academic year) in Malaysian Ringgit.

TERMS AND CONDITIONS

Admission is subject to the terms and conditions stipulated in the registration form. The school reserves the right to adjust the Fees with prior notice.

TUITION FEE DISCOUNT for 2023/2024

Sibling Discount 5% off tuition fees for the second registered sibling. 10% off tuition fees for the third registered sibling. The highest rate of eligible discount is offered to the youngest sibling. Applies to the student's sibling(s) who are enrolled in Havil International School.

Advance Fee Payment 5% off tuition fees. Applies to parents who pay the full tuition fees for three (3) academic terms.

Havilian Referral Programme RM1000 rebate for each new family enrolled. Capped at RM2000 max for two and above successful referrals. Applies to parent who successfully refer their friends to have their children enrolled in Havil International School. Terms and Conditions apply.

STUDENT WITHDRAWAL POLICY

1. The application for student withdrawal can only be processed upon completion of the Withdrawal Form. Any verbal or written notification of student withdrawal that is not accompanied by the submission of the Withdrawal Form is not considered valid.
2. For new applicants: in the event an applicant decides not to enroll in the school after paying the Security Deposit, the fees will be refunded only if a written notice is submitted to the school at least four (4) months before the date of commencement of the school term as stated in the Letter of Offer.
3. For current students: to qualify for the refund of the Security Deposit, the following terms must be complied with :-
 - a. the notice of withdrawal of the student from the School should be made in writing and received by the Admission Officer at least one (1) full academic term before the student's last study date;
 - b. The School fees must be fully paid for the one (1) full academic term withdrawal notice period (regardless of whether the student attends school during notice period duration) or right up to the student's last study date, whichever earlier; and
 - c. There is no outstanding amount owed by the students to the School.
4. All student withdrawals are subject to an administrative charge of RM100 per student. If there are any refunds applicable, a cheque will be issued by the School within two (2) months from the student's official last day of the school. Refunds are subject to terms and conditions.
5. The full terms and conditions for student withdrawal are contained in the Withdrawal Form.
